- b. Maximum Age to apply for Associate Professor Post: 55 years

- d. For the purpose of age calculation, the cut-off date will be 01-08-2024.
- e. Age relaxation, if any, will be provided as per the UGC regulations and in accordance with the guidelines approved by the Government of Jharkhand.
- f. As per the specified conditions, eligible candidates who attain maximum age (i.e. retirement age) of 65 years will not be considered for appointment to the advertised post, if they attain the age of 65 during the selection process

3. PAY-SCALE:

The Pay scale of Professor/ Associate Professor/ Assistant Professor shall be same as recommended by the University Grant Commission from time to time and accepted by the Government of Jharkhand.

4. ELIGIBILITIES:-

a. FOR PROFESSOR POST (A or B):

<u>A</u>.

- 1. An eminent scholar with Ph.D. qualification(s) in the concerned/allied/relevant discipline and published work of high quality actively engaged in research with evidence of published work with a minimum of 10 publications as books and/or research/policy papers.
- 2. A minimum of ten years of teaching experience in University/College, and/or experience in research at the University/National level Institutions /Industries, including experiences of guiding candidates for research at doctoral level.
- 3. Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process.
- 4.A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in the UGC Regulations, 2010, on the subject, as amended from time to time.

OR

<u>B.</u>

i. An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/allied/relevant discipline, to be substantiated by credentials.

b. **FOR ASSOCIATE PROFESSOR POST:**

- 1.Good academic record with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- 2.A Master's Degree with at least 55% marks (or an equivalent grade in point scale wherever grading system is followed).
- 3.A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/Industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers.
- 4. Contribution to education innovation, design of new curricula and courses, and technology-mediated teaching learning process with evidence of having guided doctoral candidates and research students.

5. A minimum score as stipulated in the Academic Performance Indicator (API) +based Performance Based Appraisal System (PBAS), set out in the UGC Regulations, 2010, on the subject, as amended from time to time.

c. FOR ASSISTANT PROFESSOR POST:

- 1. A candidate should have throughout good academic record with minimum 55% marks at the Master's degree or equivalent (or equivalent grade) in the relevant subject.
- 2.A candidate must have passed National Eligibility Test (NET)/Jharkhand Eligibility Test (JET) or equivalent test accredited by U.G.C.

Important:

- a. A relaxation of 5% may be provided at the Graduate and Master's level for the Scheduled Castes/Scheduled Tribes/Differently-abled (Physically and Visually differently-abled)/Other Backward Classes (OBC)(Non-Creamy layer) categories for the purpose of eligibility and assessing good academic records during direct recruitment to teaching positions.
- b. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
- c. The candidates who have obtained Ph.D. Degree on the basis of UGC prescribed Minimum Standard and Procedure Regulations 2009, as amended vide 2016 Regulations, shall be exempted from the requirement of minimum eligibilities of NET/JET.
- d. Provided further, the award of degree to candidates registered for the M.Phil./Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bylaws/ Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of NET/JET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-
 - 1. Ph.D. degree of the candidate awarded in regular mode only;
 - 2. Evaluation of Ph.D. thesis by at least two external examiners:
 - 3. Open Ph.D. viva-voce of the candidate had been conducted;

- 4. Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in refereed journal;
- 5. Candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D. work.
- 6. (a) to (e) as above are to be certified by the Vice-Chancellor / Pro-Vice-Chancellor / Dean (Academic Affairs) / Dean (University instructions).
- e. NET/JET shall also not be required for such Masters Programmes in disciplines for which NET/JET is not conducted.

5. SELECTION PROCESS:

Screening of applications and selection procedure will be in accordance to the rules and regulations recommended by the University Grant Commission from time to time and accepted by the Government of Jharkhand.

6. <u>RESERVATION BENEFIT</u>:

- a. Reservation benefit will be provided to permanent resident/s of Jharkhand.
- b. A scanned copy of residential certificate in the prescribed format as contained in the letter no. 4650 dated 02/06/2016 of the Department of Personnel, Administrative Reforms and Rajbhasha, Government of Jharkhand issued at the level of Sub-Divisional Officer in case the same is issued on 02/06/2016, is to be submitted to avail the benefit of reservation

Or

The residential certificate in the prescribed format as contained in the letter no. 5752 dated 19/07/2019 of the Department of Personnel, Administrative Reforms and Rajbhasha, Government of Jharkhand issued at the level of the Circle Officer in case the same issued on 19/07/2024 and onwards, is to be submitted to avail the benefit of reservation

c. A scanned copy of caste certificate issued by the District Magistrate/ Deputy Commissioner/ Sub-Divisional Officer of district/ subdivision in the prescribed format as per the norm prevailing in the State Government in case the same is issued before 25.02.2019, is to be submitted to avail the benefit of reservation

Or

The caste certificate in the prescribed format as contained in the letter no. 1754 dated 25/02/2019 of the Department of Personnel, Administrative Reforms and Rajbhasa,

Government of Jharkhand issued at the level of the Circle Officer in case the same is issued on 25/02/2019 and onwards, is to be submitted to avail the benefit of reservation

➤ Important:

- 1.It is mandatory to present Caste and Residential Certificate in original at the stage of document verification. Failing to it may lead to cancellation of candidature.
- Reserved category candidate may apply for the post reserved for Un-reserved category. However, no benefit of reservation will be provided to such candidates.
